## 12. On-line ticket sales

The tournament organizer will be administer data, i.e. store, process and, if necessary, transfer to entities belonging to the Skawinski Dance Group and cooperating with it, in particular for the purpose of implementing appropriate actions or activities, continuous improvement of customer service and informing about Skawinski Dance Group products or special offers. a) Participation in the tournament is voluntary and tantamount to consent to the processing of personal data, including image.

b) The administrator of personal data, including the image of the tournament participants, is Stardance Dance Club and Dance Team Wrocław

c) Personal data, including the image, will be processed in order to promote and build a positive image of the Tournament Organizer, being the Data Administrator, on Facebook, in the press and in materials promoting the tournament. **27. Covid Terms:**

1. Participation in Stardance Festival 2022 is tantamount to accepting the COVID-19 regulations and with the obligation to comply with it.
2. Disinfection of hands is obligatory before entering the hall.
3. Be especially careful and keep the distance of 1.5 m in queues and on the premises of the facility.
4. Before entering, each person will be subjected to a temperature measurement (people whose temperature does not exceed 37.5 degrees can enter the premises)
5. Coaches and guardians are required to cover their mouth and nose with a mask or helmet in the tournament area - the entire hall. On the other hand, dancers and judges are obliged to wear a mask or helmet everywhere except the dancer's zone and the dance floor.
6. People who will not comply with the Covid regulations may be asked to leave the hall.
7. Each dancer, trainer, guardian is required to submit a written declaration that he / she does not have contact with sick or quarantined persons and that he / she does not show symptoms of diseases indicating COVID-19. (the content of the statements at the end of the regulations - please come with the statement written out so as not to extend the entrance to the hall)



8. The registration of pairs takes place without the starter books and dancer cards.

9. Bib numbers are one-time - non-returnable.

10. There will be a group presentation of pairs at the beginning of each block. After the judges are presented, the competition begins immediately. 11. In order to avoid larger clusters in the cloakrooms, prizes will be issued every 2-3 categories, please stay close to the dance floor at all times and carefully listen to the announcer's announcements about the awarding of prizes. 12. The cloakrooms for dancers will be divided into blocks: Please pay attention to the inscriptions on the cloakrooms to which block the given cloakroom is assigned. - changing rooms in Block I -> disinfection and ventilation of these changing rooms in Block III - changing rooms in Block II -> disinfection and ventilation of these changing rooms in Block IV
